Question 1

RFA Response

Pricing should be done on the quantities specified in the pricing schedule. However, as indicated in the TOR, the actual procurements for years two and three may vary, the quantities and requirements for hardware and software for year two and three may differ (be less, but the ceiling will not be exceeded).
